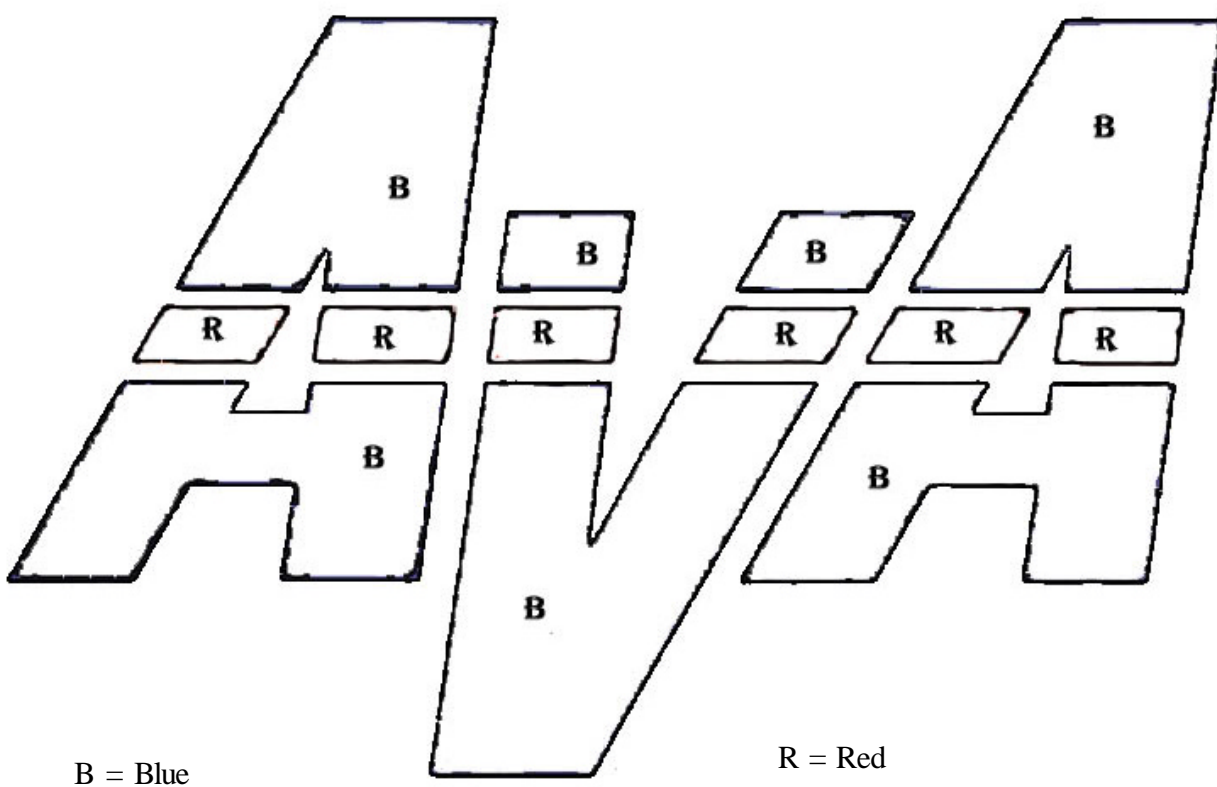

die Kinder Walkabout Program

This is a special program to encourage parents to do recreational walking with their children. The Trotting Texas Turtles Volkssport Club out of Killeen, Tx is hosting ten afternoon walks on Sunday Afternoons. The route is stroller friendly, but parents are encouraged to let their children out of the strollers and walk as much as they are able. The walk route is a 5K (3 miles) loop on the new section of the riverwalk in Waco.

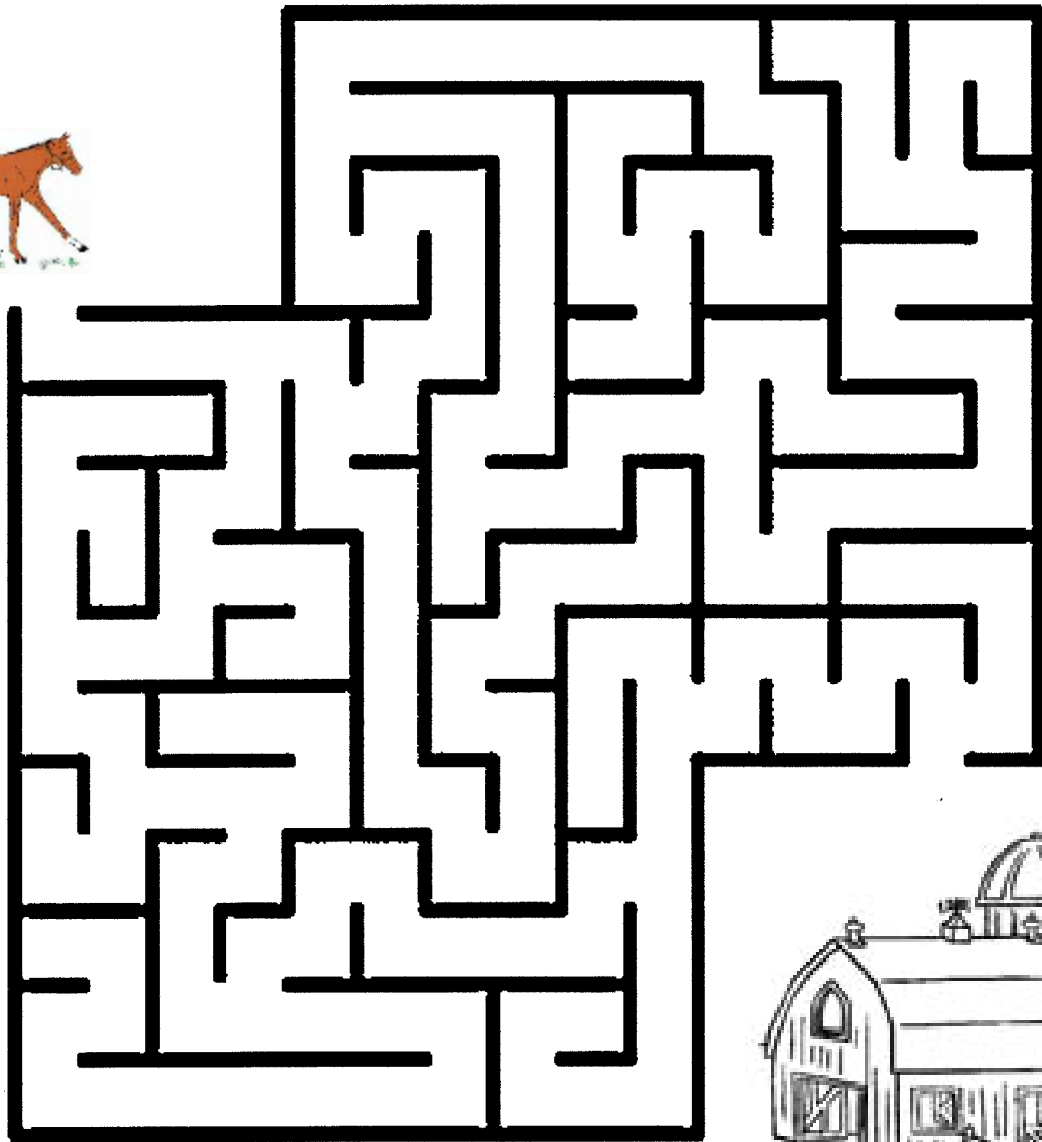
If you would like to participate with your child, bring him/her (or them if you have several) to the start location at Indian Springs Park near the Suspension Bridge. Each child will be given a FREE program record book with 10 squares on it. Each time the child completes one of the walks the program book will be stamped. If the child does all 10 events, the completed book can be turned in at the last walk and the child will be given the opportunity to choose an award. The award will be an embroidered patch or a metal from a previously held Trotting Texas Turtle Event. This award will be FREE also.

Die Kinder Walkabout events will have a registration window of 1pm-2pm. The group walk will start at 2pm. There will be a walk guide walking behind the group to make sure no one gets left behind. The walk will also have a guide at the front to lead the way. You will have until 5pm to finish the walk. If you complete it in that time the child's book will be stamped. So if you and your child decide to sit down and rest occasionally you should have ample time to complete the walk.

These walks will be held regardless of weather. We walk rain or shine. There is a bathroom available at the walk start. We recommend that you carry water to drink. You are cautioned to dress appropriately in layers so that you can add a jacket or take it off as the temperature dictates.

There is a waiver on the inside back cover of this booklet. The waiver must be completed and turned in before you and your child(ren) can participate in die Kinder Walkabout program. If you forget to bring it with you there will be ones available at the start table, but it is much easier and faster to register if you bring a completed form with you.

Volksmarchers have a trail to follow. Can you help the colt follow the trail to the barn?

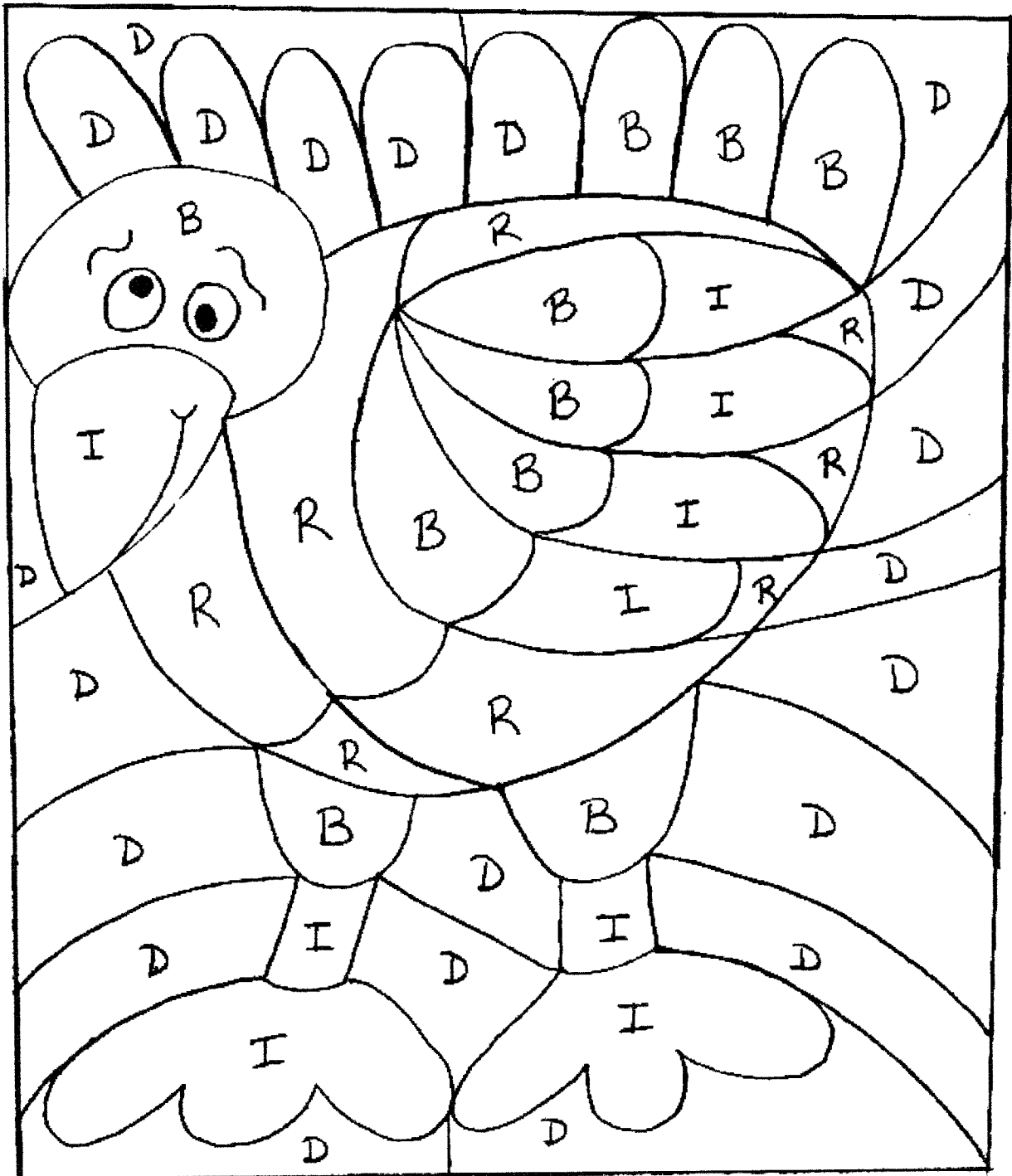


B - **blue**

I - orange

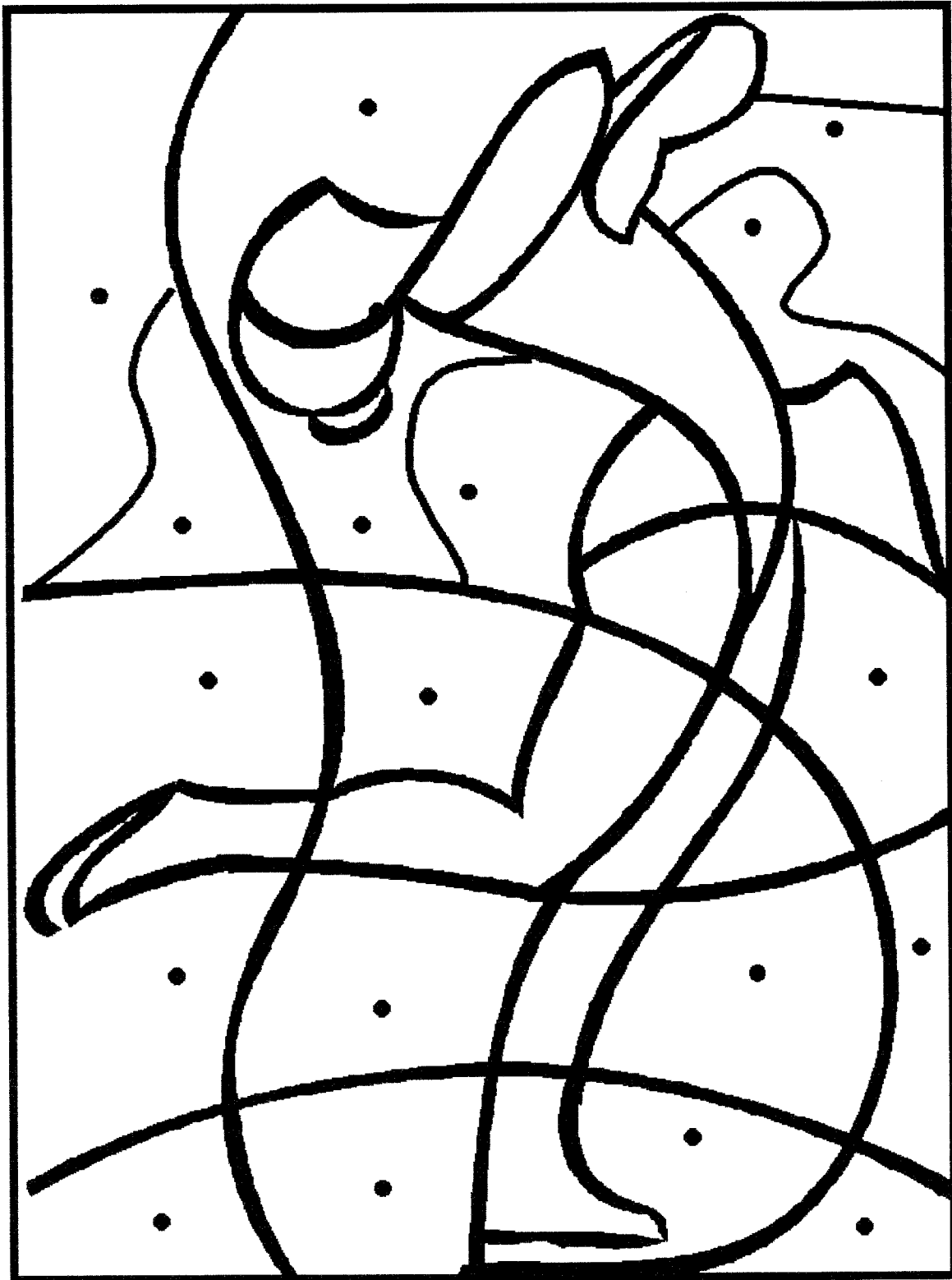
R - red

D - yellow

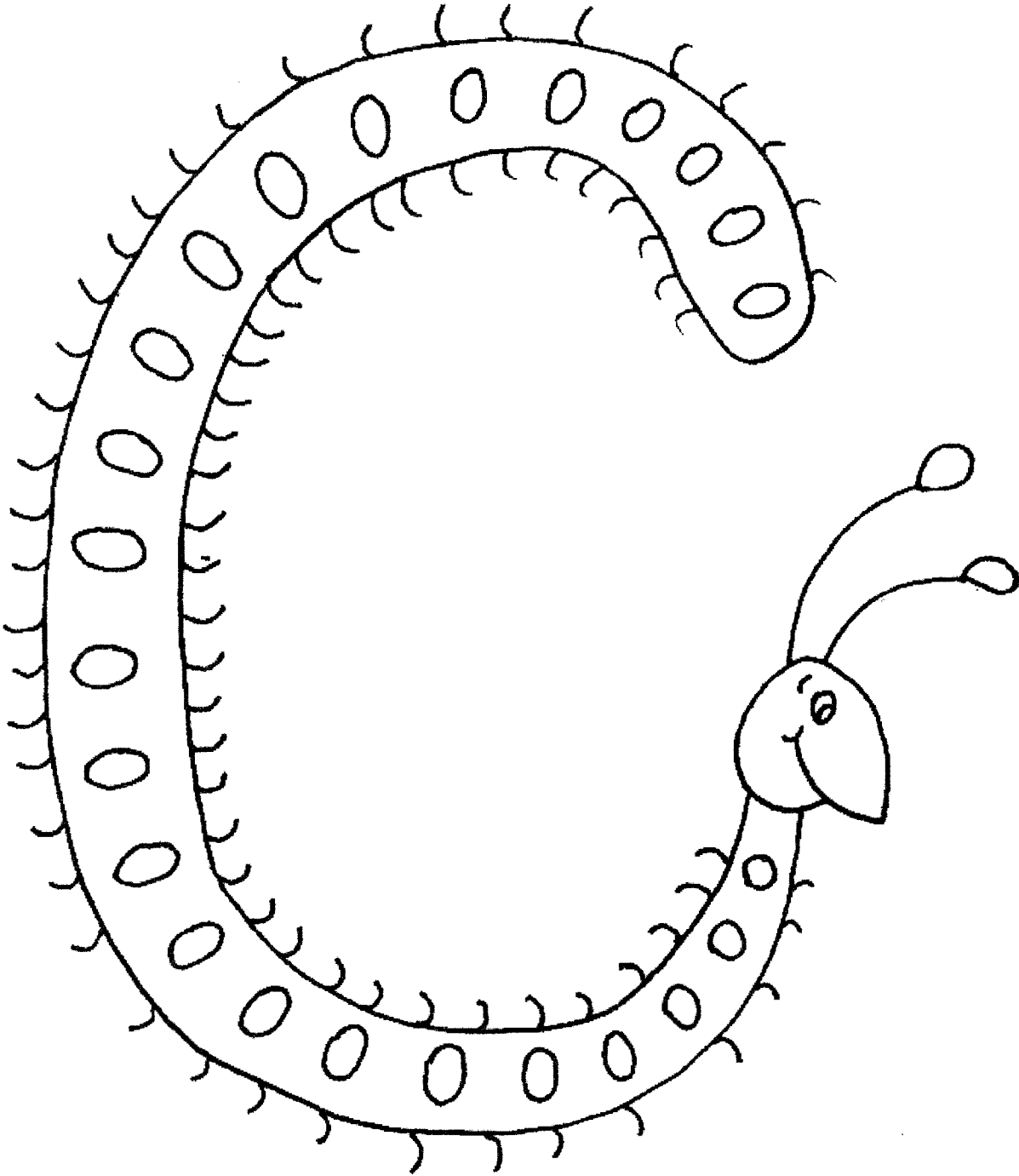




FOLLOW THE DOTS

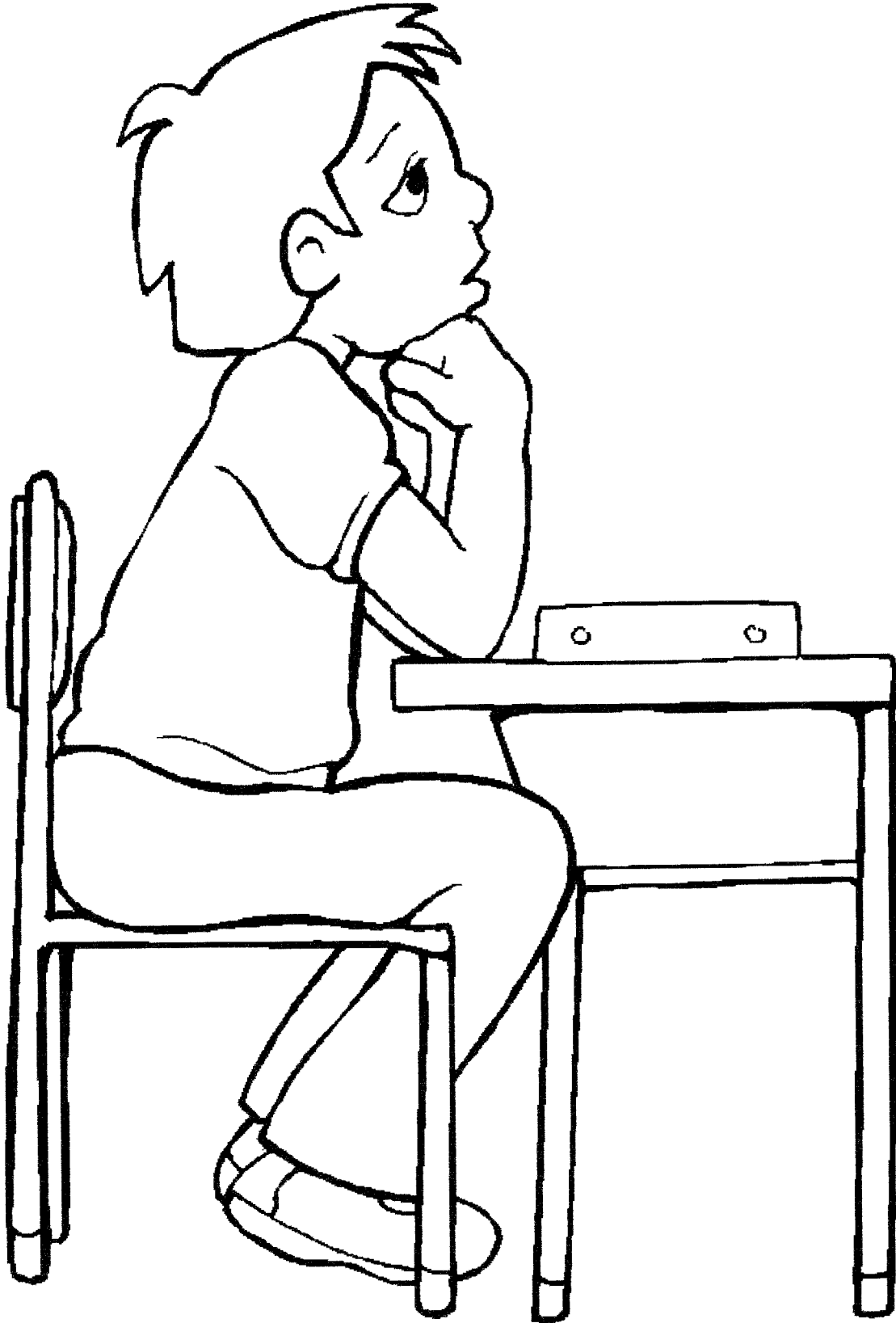

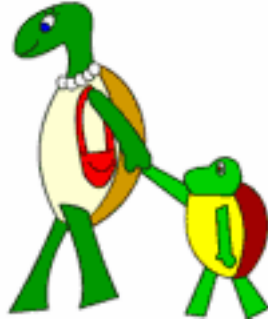

Amateur Athletic Waiver and Release of Liability

MINOR WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in die Kinder Walkabout programs and related events and activities, the undersigned:

1. Agrees that the parent(s) and/or legal guardian(s) will instruct the minor participant that before or during his or her participation, if the participant believes anything is unsafe, the participant will immediately advise the event supervisor or other person in authority at the program and the related events and activities of such conditions and refuse to participate;
2. Acknowledges and fully understands that each participant will be engaging in activities that could involve the risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own actions, inactions or negligence of others, or the condition of the premises, the trail or any equipment used. Further that there may be other risks not known to us or not reasonably foreseeable at this time;
3. Assumes all the foregoing risks and accept personal responsibility for the damages following injury, permanent disability or death;
4. Release, waive, discharge and promise not to sue the organizers of die Kinder Walkabout program, its affiliated clubs, their respective administrators, directors, agents, or other volunteers and employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.

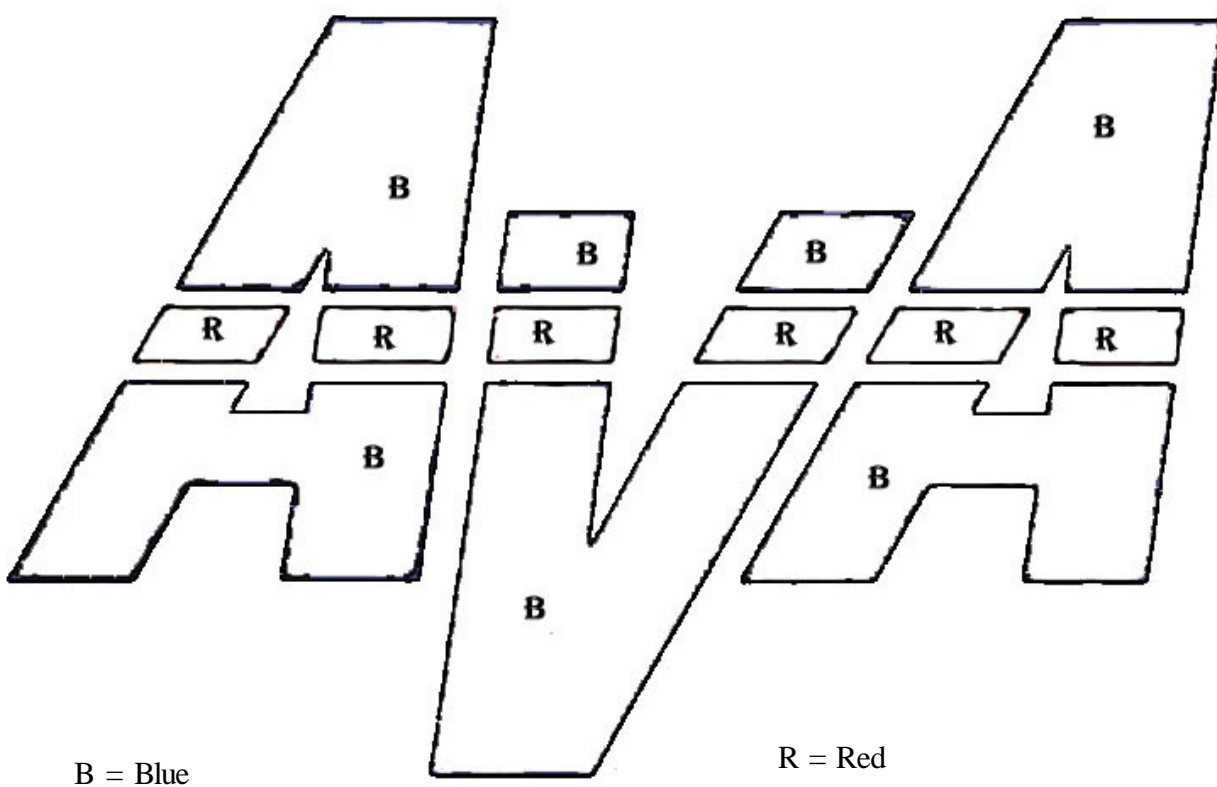
