DRIVING DIRECTIONS FROM PLAINVIEW

DIMMITT

Start Point: turn right on I-27 frontage road to TX-194; left on TX-194 to US-385; continue on US-385 to Bedford St., then turn right and park in front of the Courthouse, 100 N. Main Street.

FARWELL

Start Point: right on I-27 frontage road to US-70/Olton Rd.; left on US-70/Olton Rd. to US-84/US-70 in Muleshoe; right on US-84/US-70/W. American Blvd. to 3rd St. in Farwell; left on 3rd St. to Courthouse, 401 3rd Street.

HEREFORD

Start Point: right on I-27 frontage road to TX-194; left on TX-194 to US-385 in Dimmitt; north on US-385 to US-60/E. 1st St. in Hereford; right to Main St.; left to 3rd St.; right to Courthouse at 235 E. 3rd Street.

LITTLEFIELD

Start point: take I-27 south to FM-54; right on FM-54 to Phelps Avenue in Littlefield; left on Phelps 3+ blocks and park on Phelps between 5th and 6th Streets.

LEVELLAND

Start Point: take I-27 south to FM-54; right on FM-54 to FM-179; left on FM-179 to County Rd. 5000/FM-597; right on FM-597 through Anton to US-385; left on US-385 to Houston Street in Levelland; right on Houston to Avenue G and park at Courthouse (802 Houston St.).

MORTON

Start Point: right on I-27 Frontage road to US-70/Olton Rd.; left on US-70/Olton Rd. to Muleshoe; continue south on TX-214S/S. 1st St. to Courthouse at 100 N. Main St. in Morton; park on Main between Wilson and Washington Avenues.

MULESHOE

Start Point: turn right on I-27 Frontage road to US-70/Olton Rd.; LEFT on US-70/Olton Rd. To W. Avenue D in Muleshoe; right on W. Ave. D to parking lot between Courthouse (300 S. 1st St.) and Library.

TULIA

Start Point: North on I-27 to Exit 61, US-87 toward Kress; north on US-87 to SW 2nd St. in Tulia; right to S. Maxwell Ave., turn left and park at Courthouse, 119 S. Maxwell Avenue.
